- 2. Appointments: We are scheduling follow-up appointments that are essential for refilling expiring prescriptions or addressing emergent concerns. No new patients or procedures are being scheduled at this time.
- 3. Opioid pain medication If you do not have remaining medication or refills through July 31, 2025, please call immediately to schedule a follow up. We cannot provide prescriptions over the phone for any restricted substances past 3 months since your last appointment.
- 4. Other Prescriptions or Concerns Please call within the next two weeks if you need refills or have other medical concerns, although we will be responding to messages until at least July 16, 2025.
